GONGING WILD gradually came over during the early stages, set the pace and widened into midstretch then maintained a safe margin. SHAMUS ON ME near the rail on the turn, raced between foes nearing the sixteenth pole and earned the place. DRESS BLUES was in tight leaving the gate and checked, advanced on the turn and raced four wide into the lane and finished gamely. BUDDY PRINCESS chased and yielded in the drive. SHE'S ONLY A DREAM chased and near the rail on the turn, also yielded in the drive. WARRENSMYSTERYDICE was near the inside on the turn and lacked the needed rally. LIL STORMIN TORIE chased inside and weakened in the drive. BERRY VALID bumped leaving the gate, raced wide turning for home and lacked a rally. OFFICER LUSK outrun early, raced wide turning for home and lacked a bid. DARING DRACO stumbled when clipping heels early, dropped back and raced very wide on the turn. MEET ANZI was hung very wide on the turn losing all chance. Following a stewards inquiry, GONGING WILD was disqualified from first and placed tenth for backstretch interference.
