GLENCO KID lagged early, angled out in the upper stretch, closed with a rush and got up near the wire. HAZARDOUS was slow early outside, went seven wide leaving the turn, bid gamely, dueled late and was caught near the wire. RED ZEUS pressed the pace three across, challenged for the lead on the turn, dueled to late stretch, assumed command and was outfinished in a game effort. BRENDA'S BAR stalked inside, rallied off the rail, lacked room near the sixteenth pole and closed once clear. UNCLE DAVE lagged outside, went eight wide at the top of the lane and finished well, gaining late. GADSDEN PURCHASE pressed the pace four across, challenged for the lead on the turn, dueled through the stretch but didn't have enough late. OSO CATY raced between horses to the turn, vied past the eighth pole and gave way. HARD NINE vied inside to the turn and gave way. DONTMESSWITHKITTEN pressed the pace five wide, weakened in the drive and faded from contention. MARK broke in, showed brief speed, fell back and finished evenly. PULAYAR MAHAGAN was off very slowly and steadied at the start, trailed the field and was not urged.
