MANOVAN set all the pace from the inside, dug in gamely inside the sixteenth pole and prevailed under strong encouragement. LORD KIPLING stalked the pace, raced three wide in the lane and finished gamely to just miss. GUCCIONE was allowed to settle early, moved up four wide into the upper stretch and finished willingly to the wire. SMOOTH CART stalked the pace, raced along the inside into the upper stretch and had no final winning bid. TAKEITTOTHEBANK raced three wide and had no response. THOUGHTUWASATOAD was slow early, moved up five wide and never was a serious threat. SUPER CALL was unhurried early, raced three wide throughout and weakened. TELL BRETT broke in a tangle, raced towards the inside and never menaced. CHOCOLATE REEF was off slowly, raced four wide and never threatened. RUNAWAYFROMEM was forced five wide around the first turn and raced back throughout. MR. SADDLER showed little. WESTFEST stalked the pace and tired.
