FIFTY PROOF, prominent from the outset, was headed and forced the pace, bid into the turn and gained a short lead, turned back a rival at the head of the stretch and held sway under a drive. CHIEF COUNSEL pressed the pace, chased hard late turn and finished all out. SANGORE settled well off the early pace, was hustled angling from the rail to four-wide on the turn then rallied belatedly. RAGING STAR stalked the pace, was roused four-wide late turn, launched an all out drive but evened out in the late stages. OFFICEINTHEVALLEY led early well in hand, was headed and forced the pace on the turn, failed with a bid inside the leader at the top of the stretch, failed to match strides and tired. DELAFORCE stalked the pace, chased five-wide into the stretch, was roused but showed no response.
