NORTHERN PASSION raced off the early pace, closed inside rivals late turn, took command with authority at the top of the stretch and held sway under light handling. DENE COURT stalked the pace in hand, was set down at the top of the stretch and finished under an all out drive. CASA LOMA, rated up close early, chased on the turn and was all out through the stretch. AWESOME FIRE raced off the pace, chased into the stretch then evened out in the late stages. ROSE AND SHINE settled in range, was hustled four-wide late turn but was never a threat, LOGAN'S PEAK raced off the pace from between rivals, chased on the turn then lacked a strong closing response. CITY TRIP assumed the early lead, set the pace, was passed at the top of the stretch and tired.
