Footnotes

DULCE ESPARENZA raced midpack, closed three to five-wide on the far turn, bid in the final furlong and prevailed, driving. FOREST MAID, in range, closed four-wide late turn, bid upper stretch, battled determinedly but was outfinished. TABANKA broke inward, raced midpack, closed five-wide into the stretch and finished gamely. BUBBLES TO THE TOP pressed the pace, took command into the far turn, was always pressured and tired midstretch. AONE SAUCY MISS raced midpack, was hustled on the far turn and finished all out. NIIGON'S PRINCESS broke outward, stalked the pace in hand, was hustled along the rail on the far turn then tired midstretch. STAY CLEAR raced midpack, was asked for run late turn but failed to menace. JOVI BEGONE raced off the pace, was hustled four-wide into the stretch but never reached contention. KALYPSO KERRY raced midpack, chased six-wide late turn and evened out

in the stretch. MY LADYSHIP, always well off the pace, angled from the rail to three-wide on the far turn but lacked a rally. FAIRY ROAD, off slowly, raced well back, was hustled on the far turn, came five-wide into the stretch but failed to threaten. SASTA raced midpack, was roused late turn but showed no further response. CHANTE DAN had inside speed, set a reserved pace although under pressure, was headed at the far turn, chased briefly and tired. T' RUCKUS settled well back early, trailed the field, was roused on the far turn but showed no response.
