COMMERCIAL FREE closed three-wide late turn, cut to the rail at the top of the stretch, bid midstretch and prevailed, driving. JOANNIE NOT JO chased along the rail, came out under left-handed urging upper stretch and brushed COUNTY DREAMER, bid midstretch but was outfinished. TORCHY KINSHASA, well back three and four-wide, rallied belatedly outside. KRIS'S HONOR raced off the pace, was hustled three-wide then four-wide late turn but evened out late. BOLD VERONA had speed, set the pace, was all out in the stretch and tired. EXPLOSIVE GREEK chased on the turn, flattened out in the stretch. COUNTY DREAMER forced the issue in hand early, chased into the stretch, was brushed upper stretch and stopped despite rousing. GROOMSMAN raced off the pace along the rail, lacked a rally. A CLAIM OF FOUL BY THE RIDER ON COUNTY DREAMER AGAINST JOANNIE NOT JO FOR INTERFERENCE UPPER STRETCH RESULTED IN JOANNIE NOT JO BEING DISQUALIFIED AND PLACED SEVENTH.
