

## **Footnotes**

HOOH WHY was unhurried to the far turn, closed swiftly and took command at the top of the stretch, turned back MILWAUKEE APPEAL upper stretch and held TASTY TEMPTATION safe under a drive. TASTY TEMPTATION, well back early, was hustled four and five-wide on the far turn, angled out upper stretch, bore in a bit but gained steadily in the late stages. MILWAUKEE APPEAL raced off the pace, closed through the far turn, was hustled five-wide into the stretch, launched a bid upper stretch but failed to match strides. BEAR'S LIGHTNING, close early, settled and stalked the leader from afar, chased on the far turn then evened out late. DOUBLE MALT, well back early, was hustled three and four-wide on the far turn then rallied belatedly. DANCE FOR US settled well back, closed on the far turn then lacked the necessary rally. POLITELYPRECOCIOUS raced off the pace, came three-wide through the far turn then evened out in the stretch. WOODSMOKE led into the first turn, drew off a long advantage, relaxed on the backstretch, had command to the top of the stretch and tired. YUKARI broke in a tangle and was never a factor.
