WINDWARD ISLANDS pressed the pace from the second path, challenged late turn, dueled into the stretch, drove clear midstretch then held under steady handling. SAFETY ZONE gained a short lead on the backstretch, set a pressured pace, was engaged late turn, dueled into the stretch, was headed midstretch, dug in late but missed. TORQUAY broke alertly then was taken under strong restraint, settled on the turn, stalked three-wide, lodged his bid upper stretch, failed to match strides and was all out to save third. COBOTOWN RON rated kindly, raced along the second path in range, was set down at the top of the stretch and finished well to no avail. TRACKERMAN raced off the pace, saved ground, was all out in the stretch but lacked a strong response. GUADALCANAL settled early, was roused three-wide late turn but lacked a stretch response.
