Footnotes

RIDING THE RIVER raced off the pace, closed along the rail then two-wide through the turn, launched his charge split foes in deep stretch bumping with FORBIDDEN BEAR then prevailed, driving. KID CANUCK forced the pace, bid late turn, gained command upper stretch and drove clear but failed to hold late. GYPSY RING, rated midpack, was hustled five-wide late turn then rallied willingly outside. FORBIDDEN BEAR set a pressured pace, was engaged late turn, gave way grudgingly upper stretch, was still close in deep stretch, bumped with RIDING THE RIVER and was through. SAY NO MORE stalked three and four-wide, chased into the stretch then flattened out in the late stages. PASSAGER (FR) trailed the field, swung four-wide late turn, chased, but did not menace. EVEN raced midpack, came three to five-wide through the turn then finished evenly. THE BOY'S RING stalked from the rail, angled out a bit late turn, chased into the stretch then tired in the late stages. BEAR'S PROSPECTOR raced off the pace, was hustled on the turn angling from the rail to three-wide then tired in the stretch. THERE WAS A STEWARDS' INQUIRY INTO THE INCIDENT IN DEEP STRETCH AND A CLAIM OF FOUL BY THE RIDER ON FORBIDDEN BEAR AGAINST RIDING THE RIVER FOR INTERFERENCE IN DEEP STRETCH. THE RESULTS WERE LEFT AS POSTED.
