APPROVAL RATING raced midpack, closed four-wide midturn, bid at the 1/4 pole then drove clear upper stretch and widened under a drive. SKIP CODE forced the pace from early backstretch, chased two-wide then four-wide late turn, bid at the 1/4 pole but was no match for the winner in the stretch. ANGEL OF THE HOUSE raced off the pace, closed three-wide on the far turn, was fanned five-wide at the top of the stretch, gained slightly then hung late. FORBIDDEN BEAR broke inward, took the early lead, set a pressured pace, was engaged late turn then tired in the stretch. STRIKE IMPACT stalked three-wide on the backstretch, bid late turn then flattened out in the stretch. BILBO, in touch along the rail, failed with a bid at the top of the stretch and tired. OURTIMETODANCE trailed throughout along the second path.
