### Footnotes

ATLANTIC HURRICANE moved up and forced the pace late backstretch, bid late turn, had command upper stretch and widened under a hand ride. BODUA raced midpack, closed into the stretch and moved to the rail, angled out midstretch and finished determinedly. CHURCH VIEW raced midpack, closed into the stretch, lost her path midstretch then chased to the end. TIGRA MARA stalked the pace, was set down upper stretch but evened out in the late stages. COZY CABIN raced off the pace, closed angling out five-wide late turn, rallied mildly but was not a threat. RENAISSANCE GIRL raced midpack, came three and four-wide through the turn then finished under steady pressure through the stretch. COURT GOWN (IRE), rated off the pace, was hustled through the

turn while angling from three to five-wide and finished gamely in vain. SOUND OF THUNDER, in touch, came three and four-wide through the turn, chased into the stretch, launched an all out drive but tired in the late stages. STAGE TRIP stalked along the rail, was hustled through the stretch then failed to menace. ANDTHE SKIPPER TOO led early, set a pressured pace from late backstretch, dueled into the stretch, yielded upper stretch and tired. DIXIE STAMP raced off the pace, saved ground but never reached contention. THERE WAS A STEWARDS' INQUIRY INTO THE STRETCH DRIVE AND A CLAIM OF FOUL BY THE TRAINER OF CHURCH VIEW AGAINST BODUA FOR INTERFERENCE IN THE STRETCH. THE CLAIM OF FOUL WAS DISALLOWED AND THE RESULTS WERE LEFT AS POSTED.
