Footnotes

MISSY IN ACTION was unhurried early along the rail, angled out midway through the turn, came four wide in the drive and was full of run outside of the leaders, assumed command in the final furlong and drew clear under mild urging. STEPHANIE'S WAGER sprinted to the early lead and was in hand just off the rail, drew clear on the turn, but gave way in mid stretch and held place gamely. MY REAL QUIET LADY was pinched back at the start and unhurried early, made a quick move three wide on the turn and closed the gap, but flattened out in the stretch. SLEWANNA was allowed to settle inside of rivals, angled out in upper stretch, but never rallied and was never a threat. MAGGIE ROSE was void of early speed, made a mild bid on the turn and moved to the rail entering the stretch shutting off SEQUENA, then flattened out in the drive. WIND CHILL FACTOR raced wide in the early going and was in hand pressing the early pace, then weakened in the stretch. SOQUENA bore out at the start and bumped with rivals to the outside, recovered quickly and pressed the early pace inside, clipped heels entering the stretch and dropped back. CASHMERE stalked the early pace three wide, then tired on the turn and dropped back. DEVILISH LADY was unhurried early inside of rivals, then dropped back on the turn and was outrun. Following the race, there was Stewards' inquiry for possible interference in the vicinity of the quarter pole. After reviewing the tapes, the Stewards disqualified MAGGIE ROSE for interfering with SOQUENA entering the stretch and disqualified her from fifth position and placed her seventh.
