BANNER BILL bobbed at the start, raced off the pace, closed six-wide on the turn, loomed at the top of the stretch, took command quickly and drew off under light handling and finished under a hand ride. SAFRACTION raced off the pace, chased hard four and five-wide on the turn, was game in the stretch and finished best of the rest. FIREFALL dueled from the outset, was headed briefly on the turn, rebid late turn, wore down his but was passed upper stretch then evened out. THREEANDDONEDAN stalked the pace, chased four and five-wide through the turn then flattened out in the final furlong. GIN JOINT dueled on the backstretch, led briefly on the turn, vied into the stretch and tired. STARK RAVIN MAD, off a step slowly, chased up close on the backstretch then faded three and four-wide on the turn and lacked a rally. DISTINCTLY DONOVAN bobbed at the start, raced off the pace between rivals, was squeezed back at the turn and was eased. A CLAIM OF FOUL BY THE RIDER ON DISTINCTLY DONOVAN AGAINST BANNER BILL FOR INTERFERENCE ENTERING THE FAR TURN WAS DISALLOWED AND A STEWARDS' INQUIRY INTO THE INCIDENT LEFT THE RESULTS AS POSTED.
