CHIEF COUNSEL tracked the early leader, bid 3-wide into the stretch then was full out in the drive to the wire and prevailed over inside foe. ELUSIVE BEAT in mid pack, saved ground, closed and bid between turning for home then dueled to the wire from inside and missed. CHIEF BEAR was off the pace, gained ground on the far turn and finished willingly to best the rest. THUNDER BALL in mid pack, bid from the four path into the stretch and finished off a mild try. SHELLBACK came from off the pace to put in a late inside try to no avail. LITTLE RED CHRIS in mid field and a factor on the far turn, lacked the needed kick. LIFES NOT A BREEZE chased the speed into the far turn then tired. INTERCOASTAL had speed, led the way and was on the engine and inside into the stretch then faded. RED RIVAL was well back and never came close. CARCILLO tracked the speed into the far turn then faded.
