**Footnotes**

CASUAL DUDE unhurried in the early going, made up ground into the stretch from off the rail then rallied and was four wide in the drive to the wire while arriving just in time. COFFEE BAR never far back, tracked the leaders while off the rail on the turn then bid and was in the mix to the wire only to miss late from between foes. WOOD DALE was up on the pace then between foes on the turn, kept it going and was game to the wire. SEPTEMBER SQUARE just back of the early leaders, bid inside in the run to the wire only to be outfinished. GUISEPPE raced in mid pack and then had a mild off the rail rally.

FEDERAL COURT pressed the pace and was three wide on the turn then evened out in the stretch run. SCOPIN' U OUT inside early, angled out, bid wide but did not have enough. MIGHTY MONARCH had speed to vie for the lead, was inside rivals on the turn then weakened in the drive. SOUL BLUES was well back and lacked the needed rally. ROYAL CAPTIVE raced wide through the turn and lacked a serious bid. HE'S ALL THAT settled off the pace then lacked a rally. KINGS HIGHWAY off the pace, lacked the needed bid. RAGING STAR inside early, angled out into the stretch then failed to threaten.
