**Footnotes**

FORBIDDEN BEAR forced the issue, was under pressure to continue close up on the turn, kept after the leader in the stretch and got up late under a drive. PREAKNESS LAUGHER led early, set a reserved pace although under pressure from FORBIDDEN BEAR, shook clear at the top of the stretch then was all out but failed to hold in the late stages. KNIGHTLY ATTIRE, well back early, closed mildly on the turn then rallied belatedly. RING OF GREATNESS, in range early, chased on the turn, came four-wide into the stretch but never threatened. JET SET EXEC raced off the pace, chased four-wide late turn then evened out midstretch. POWER OF ATTORNEY settled off the pace, was hustled on the turn then lacked a stretch response. PARABOLA raced off the pace, was hustled two and three-wide on the turn then tired in the stretch.
