**Footnotes**

NICOLA'S NICKERS, rated in midpack, closed between foes late turn, took command upper stretch and finished under a hand ride. SOUND OF THUNDER stalked the pace in hand, bid along the rail upper stretch but was outkicked. GOLDEN GIRL SUE set a reserved pace, was roused late turn but was headed upper stretch and gave way. GROUP HUG stalked the pace, chased late turn and finished all out. SKATING HOME stalked then pressed the pacesetter, chased five-wide into the stretch but did not threaten. EXECUTIVE SHERRI, rated off the pace, chased on the far turn but never reached contention. SOVEREIGN GRACE raced off the pace, was hustled late turn but never reached contention.
