DENE COURT broke alertly, set the pace from well off the rail, dropped in approaching the turn, continued to make the fractions from the second path, moved to the rail upper stretch then toyed with her rivals, easily staying in front to the wire. PART THE SEAS raced off the pace, closed five-wide late turn then finished under an all out stretch drive. GRAVELLY BAY, in range, came three and four-wide through the turn, was set down upper stretch but evened out in the late stages. ROSE AND SHINE raced off the pace along the rail, angled out midstretch and finished gamely in vain. WHY KATHERINE, in range along the rail, closed late turn then flattened out in the stretch. ESTELLA raced off the pace, chased two-wide into the stretch then flattened out. OSLER BLUFF, in touch between horses, stalked on the turn, chased into the stretch and tired.
