LUVYOUTOTHEMOON, in range, closed four-wide late turn, rallied gamely and got up late, driving. TIGERHEAT set a pressured pace, moved clear leaving the turn, had command to deep stretch then gave way grudgingly. I'MTRULYINTHEMOOD chased in range, launched his drive along the rail at the top of the stretch and finished all out. SWINTON settled off the pace, angled from three to seven-wide on the turn then rallied willingly, but late. YOU DON'T PASS pressed the pace three-wide, chased into the stretch but had no late response. FIRE CHIEF forced the pace four-wide, chased through the stretch but evened out at the 70 yard pole. JET SET EXEC raced off the pace, angled from four to six-wide on the turn, was hustled into the stretch then flattened out in the late stages. BEAR ALWAYS raced off the pace, was hustled four-wide into the stretch then evened out. OMEGA MINISTER pressed the pace, stalked still up close on the turn then tired a furlong out. POWER OF ATTORNEY, off poorly, trailed the field and was never a factor. A STEWARDS' INQUIRY INTO THE START FOUND THAT POWER OF ATTORNEY HAD AN UNFAIR START AND DEEMED HIM A NONSTARTER, NECESSITATING A

REFUND OF MONIES WAGERED ON HIM.
