### Footnotes

ICE DANGER hit the gate at the break, stalked the speed battle into the turn, bid three wide entering the stretch then was full out to prevail in a duel to the wire with inside foe. MIA'S MIRACLE had good inside speed to duel throughout and was game in a run to the wire but outfinished. WANDO'S APPEAL off the pace, came wide into the stretch then a mild rally brought him up for the show. GIVEMESIXSTEPS dueled from the outset, battled on the turn then weakened in the drive. DON'TPUSHMEAROUND was off the pace, wide into the stretch and bid had no impact. GOLDEN COUNTY hit the gate at the break, dueled three wide into the turn then began to weaken and faded. GUNGA DAN was off the pace and saved ground to no avail. ROY'S BOYS raced in mid pack then lacked a rally.
