Footnotes

BEAR LAHAINA stalked the pace, angled from the rail to three-wide on the turn, challenged at the top of the stretch and quickly moved clear then finished under a hand ride. TETHRA'S WORD forced the pace, chased on the turn and finished gamely in vain. MIMI COOPER raced off the pace, closed late turn, chased into the stretch but did not menace. KAIN'S VOW broke alertly but settled off the pace, cut from the second path to the rail late turn, chased into the stretch but never threatened. CLEARLY IN CHARGE raced off the pace, was hustled on the turn but was in hand late turn then finished gamely without menacing. GREENBACKHASVALUE was sent to the early lead, moved clear into the turn, set the pace, was collared upper stretch and tired. ARONIA raced midpack, was hustled along between foes on the turn, ducked out late turn and was through. A CLAIM OF FOUL BY THE RIDER ON ARONIA AGAINST MIMI COOPER FOR INTERFERENCE NEAR THE HEAD OF THE STRETCH WAS DISALLOWED.
