PLAYERS CLUB, away alertly, settled in midpack, chased four-wide late turn, launched an all out drive was up in time. MS SILVER OAK stalked three-wide, chased into the stretch, bid a furlong out, had command but failed to hold the winner safe. HARLAN'S PANTHER, bumped at the start, settled off the pace, closed late turn then rallied gamely, but late. CINDY'S JOY, bumped at the start, raced off the pace then rallied from last at the top of the stretch. COOKING SCHOOL pressed the pace, bid upper stretch, wore down the early leader a furlong out but gave way quickly. WHISPERING WALL led early, set a pressured pace but gave way a furlong out. VARIABLE RATE raced in midpack, was hustled late turn then flattened out in the late stages. NANDIRA raced in midpack, saved ground but lacked a strong closing response. IDRATHERBEATTHESPA raced off the pace, came four and five-wide through the turn, chased into the stretch then tired in the final furlong. LOOKINOUTFORANGELS settled off the pace, chased two-wide into the stretch but never reached

contention. GEE GEE'S PYRAMID raced off the pace, saved ground but tired midstretch.
