**Footnotes**

QUAESITOR settled off the pace, closed two-wide on the final turn, launched an all out charge along the rail in the stretch and was up in the final 16th and drove to the wire. ALDOUS SNOW raced off the pace, closed two to four-wide on the final turn, took a short lead upper stretch, was headed in the final 16th but stayed gamely to the end. STOLONBOY settled off the pace, chased three to five-wide on the far turn but was not a threat in the stretch. HEATHCOTE stalked the pace three-wide, forced the issue on the 2nd turn, took command mid backstretch, was headed upper stretch and gave way. SIR ANDREW led early, dueled on the 2nd turn, yielded midway of the backstretch, chased on the turn but failed to menace. CELTIC CONVICTION, rated in range early, chased on the last turn then flattened out in the final furlong. DYNAMICAL stalked the pace, dueled on the 2nd turn, gave way grudgingly late backstretch then faded on the turn.
