**Footnotes**

OH CANADA settled off the pace, was hustled four-wide on the turn, rallied outside and swept by the leader midstretch, driving. LOOKS PURRRFECT came out shortly after leaving the gate, bumped with BOSS TWEED and was knocked sideways, stayed in striking range, chased hard four-wide on the turn then rallied between rivals. EXCHANGE CAN RATE, came in a bit and bumped with BOSS TWEED just out of the gate, pressed the pace, bid four-wide late turn, was headed at the top of the stretch, rebid a furlong out and gained a short lead but was passed with a 16th to run. SHELDONS CRUSADER stalked the pace, dropped back on the turn, responded when roused and chased gamely to the wire. BOSS TWEED, bumped early, dropped well off the pace, was hustled through the turn and finished determinedly. SOLO PLAYER forced the pace, dueled on the turn, was headed at the top of the stretch, rebid a furlong out but could not sustain the move and tired. SUNDIN set a pressured pace, dueled from early turn, shook clear into the stretch, was headed a furlong out and tired. ROCKETMAN ROB stalked the pace, chased two-wide on the turn then tired in the final 16th. A CLAIM OF FOUL BY THE RIDER ON BOSS TWEED AGAINST LOOKS PURRRFECT FOR INTERFERENCE JUST OUT OF THE GATE WAS DISALLOWED.
