SANDSPIT raced off the pace, swung eight-wide at the top of the stretch, rallied smartly and got up late, driving. HOUSE OF MAGIC raced off the pace, was blocked upper stretch, split foes herding VEGAS VENTURE inward at the 1/8 pole, finished gamely and missed. GET DOWN WOLFIE stalked close up and four-wide, bid upper stretch, drove clear then faltered in the late stages. FROMAJACK TO AKING, unhurried while three-wide, swung seven-wide at the top of the stretch, rallied gamely then hung late. TORQUAY raced midpack between foes, rallied mildly inside. VEGAS VENTURE, in touch early between foes, was herded inward at the 1/8 pole then was all out to the wire. TALL COOL ONE showed speed, set a reserved pace, quickened on the turn, was headed upper stretch and tired. COGGINS HILL stalked from the rail, was squeezed back and checked at the 1/8 pole and evened out. DANCER'S GUEST trailed the field, never threatened. DISBELIEF, up close between foes, came five-deep to the top of the stretch and tired. OUT FROM AFRICA pressed the leader, launched an all out bid at the top of the stretch, could not get up to the lead and tired. A STEWARDS' INQUIRY INTO THE STRETCH RUN AND A

CLAIM OF FOUL BY THE RIDER ON COGGINS HILL AGAINST HOUSE OF MAGIC FOR INTERFERENCE IN THE STRETCH RESULTED IN HOUSE OF MAGIC BEING DISQUALIFIED AND PLACED 8TH.
