ADMITIT led briefly, was headed and stalked the pace, bid four-wide late turn, was headed at the top of the stretch, dug in and took command a furlong out and finished under a drive. GINGER MINT raced off the pace, was hustled three to five-wide on the turn then rallied late outside. TIGRA MARA raced forwardly then forced the pace on the backstretch, bid at the top of the stretch, led briefly, was headed a furlong out and chased to the wire. BOND'S BABE set a pressured pace, was headed at the turn, chased, rebid between foes at the top of the stretch, was headed a furlong out, chased but came out late under right handed encouragement. HONEY CRISP raced in midpack, was hustled four-wide late turn, rallied, lost her path and clipped heels with BOND'S BABE in deep stretch. AMERICAN PLACED raced off the pace, hustled two and three-wide through the turn but lacked a closing response. A STEWARDS' INQUIRY INTO THE STRETCH RUN CONCERNING BOND'S BABE AND HONEY CRISP AND A CLAIM OF FOUL BY THE RIDER ON HONEY CRISP AGAINST BOND'S BABE FOR INTERFERENCE IN DEEP STRETCH RESULTED IN BOND'S BABE BEING DISQUALIFIED AND PLACED FIFTH.
