SHINE FOR US was off slowly, but recovered quickly and stalked the early pace just off the rail, closed the gap very easily on the turn and assumed command entering the stretch, then drew clear under mild urging. SOUTHERN SWEET was allowed to settle just off the rail, roused three wide on the turn and finished well, but was no match for the winner. FLORIDA ON FIRE was unhurried early inside of rivals, saved ground on the turn and closed the gap exiting the final turn, moved outside of a tiring MY SKY BEAUTY in the drive and finished with a mild bid. MICAYLA'S PEACH was unhurried early outside of rivals, roused between horses on the turn and finished with a mild rally. MY SKY BEAUTY broke sharply and set the early pace in hand and unchallenged, then faded quickly in the drive. AUGURI SHARDAE was off slowly and unhurried early, swung wide on the turn, but never rallied and was never a threat. VALID WIRE broke slowly and was void of early speed, rallied along the rail on the turn and made a mild bid, but flattened out in the drive. SHOELESS SUE was hustled along four wide, then dropped back on the turn. NO BLUES TONIGHT was void of early speed and saved ground on the turn, but never rallied and was never a factor. BELIEVER'S QUEEN was void of early speed three wide and never a factor. MATTER OF JUSTICE showed brief speed inside of rivals, then dropped back on the turn.
