COUNTER MOVE was prominent on the backstretch, dropped back a little and pressed the duelers on the turn, closed four-wide and challenged near the 1/4 pole, gained a short lead at the top of the stretch, drove clear then finished under a hand ride. VERIDICUS broke alertly, settled, was hustled on the turn and angled out four-wide late turn then finished all out. VEGAS WEEKEND was hustled from off the pace on the turn, encountered traffic upper stretch, altered course sharply to the outside and finished gamely. CONFLICTING REPORT settled, closed on the turn, was blocked at the top of the stretch, split foes to go after the leaders but was steadied slightly, chased briefly and evened out. RING OF GREATNESS dueled three-wide, was headed at the top of the stretch, bumped with DANCE TO MY BEAT and tired. DANCE TO MY BEAT dueled two-deep, was headed at the top of the stretch, bumped with RING OF GREATNESS and tired. LONE ENDEAVOR showed speed, dueled from the rail, was headed at the top of the stretch, was tiring then was squeezed upper stretch and was through. SEPARATE STEWARDS' INQUIRIES INTO THE STRETCH RUN CONCERNING FIRSTLY DANCE TO MY BEAT AND RING OF GREATNESS AND SECONDLY LONE ENDEAVOR AND CONFLICTING REPORT FOUND THAT THERE WERE NO INFRACTIONS AND THE RESULTS WERE LEFT AS POSTED.
