NAME IN LIGHTS led early, set a reserved pace then held gamely through the stretch under light but steady handling. MY ISLAND GIRL, in range, was hustled four-wide on the turn, finished under a determined stretch drive, but hung. POPSICLE TOES stalked the pace, chased two and three-wide on the turn and was all out through the stretch. SWEETSOUTHERN DOLL raced off the pace, chased four to six-wide through the turn and finished determinedly. EXECUTIVE SHERRI raced midpack along the rail, was hustled on the turn then evened out midstretch. SANTA BABY raced in midpack between rivals, chased hard on the turn then evened out midstretch. BELIEVE THE FOX raced off the pace, chased late turn, came five-wide to the top of the stretch and failed to menace. HIGHLAND HOLIDAY, in midpack early, was hustled from off the pace on the turn and was never a threat. SKY HALO, in range, was hustled four-wide late turn then tired in the final furlong. SEALED BID settled well off the pace, was hustled on the turn but never reached contention.
