GOLDEN GIRL SUE led early, set a reserved pace while getting some pressure from rivals, quickened late turn then held sway under a drive. NICOLA'S NICKERS stalked the pace, forced the issue on the backstretch, chased up close on the turn and was all out through the stretch. HOLD THAT ECHO, off slowly then rated in range, closed late turn and finished determinedly. ROMAN DAMSEL, rated off the pace, angled out closing on the far turn then rallied five-wide. VINDYS LUCKYSTRIKE pressed the pace, stalked on the far turn, chased into the stretch but flattened out. OCALA DAWN, steadied at the start, rated off the pace, was hustled late turn but lacked a closing response.
