RAHY'S ATTORNEY stalked the pacesetter from the rail, moved out to the second path for the run through the turn, bid past midturn, vied briefly then drew clear approaching the stretch then held under an all out drive. VENTURA rated off the pace, closed along the rail early turn, angled three-wide late turn and was all out in the stretch but could not run down the leader. JUST RUSHING held a short lead from the rail, was engaged past midturn, dueled briefly and was headed then chased the new leader home. ICE BEAR raced just off the early pace, closed four-wide late turn, came five-wide into the stretch and finished gamely. KIP DEVILLE broke alertly and was taken under strong restraint, stalked the pace in hand then hung in the stretch. MULMUR, in range two-deep, was blocked by traffic late turn, brushed with PALLADIO at the head of the stretch then lacked a strong closing response. PALLADIO rated off the pace, closed five-wide late turn, brushed with MULMUR at the top of the stretch then lacked a strong closing response. WOLLEMI PINE, in range three-wide, dropped back a bit on the turn, swung four-wide late turn but lacked a stretch response.
