HOLLYWOOD HIT set a reserved pace, widened through the stretch finished with authority under a hand ride. BEAR TOUGH TIGER, in range, stalked four-wide on the turn and chased through the stretch. COURT OF THE REALM stalked from the rail, chased into the stretch, finished gamely and was best of the rest. EXFACTOR settled off the pace, closed late turn but never reached contention. FATAL BULLET, in touch between foes, chased two-wide into the stretch and tired. EXECUTIVE FIVE stalked the pace three-wide then tired late turn. HOLLYWOOD HIT WAS DISQUALIFIED FROM FIRST TO UNPLACED FOR A MEDICATION VIOLATION.
