DAWSON'S LEGACY pressed the pace into the first turn, was then taken back and allowed BUCK'S BOY to open a clear lead in the backstretch, drew even inside of that one in the stretch and dueled briefly, gained the lead with a furlong to go and drew clear under a drive. BUCK'S BOY assumed command in the first turn and was unchallenged in the backstretch, dueled briefly in the stretch but came up short when asked in the drive. THORNFIELD was unhurried early between horses, closed the gap in the second turn but failed to sustain the bid and dropped back. CROWN ATTORNEY was allowed to settle off the rail, made a mild bid in the second turn but failed to sustain the bid and was never a threat. VENTURI EFFECT was allowed to settle but failed to respond and outrun.
