RUCKUS IN COURT well back early, closed along the third path on the turn, bid upper stretch, drew clear quickly and widened under a hand ride. VAGE stalked the pace, closed late turn, bid upper stretch but was outfinished. HURRICANE WHIZ trailed to the top of the stretch then rallied belatedly along the rail. DANA'S LUCKY LADY broke alertly then settled, moved to the rail and saved ground on the turn but raced evenly throughout. BRIGHT ENGAGEMENT raced evenly two deep and lacked a closing response. ALL ABOUT COLOR led quickly, set a reserved pace but yielded at the top of the stretch. NURSE BETTY settled quickly, moved to the rail, saved ground but lacked a rally. NO BEANS was through early, raced on the third path and tired badly.
