A BIT O'GOLD stalked from the rail, quickened a bit midturn then moved out between horses and closed three-wide into the stretch, rallied determinedly and gained a short advantage in the late stages. REVVED UP pressed the leader in hand, drew abreast entering the far turn, gained a narrow lead at the top of the stretch then gave way grudgingly and was still game to the end. LENNY THE LENDER checked in tight quarters late on the first turn, remained in touch on the rail then rallied between horses, got up close midstretch but hung late. LAST ANSWER stalked the pace, quickened four-wide late turn, was all out in the stretch but evened out. STRUT THE STAGE rated early, was roused between foes late turn but lacked a strong closing response. DEMETEOR set a reserved pace, was engaged entering the far turn, raced forwardly but was headed at the top of the stretch then gave way grudgingly. COLORFUL JUDGEMENT was prominent three-wide, began to give way and was hustled on the far turn but tired in the stretch. A CLAIM OF FOUL BY THE RIDER ON LENNY THE LENDER AGAINST A BIT O' GOLD FOR INTERFERENCE ON THE CLUBHOUSE TURN WAS DISALLOWED.
