FOR THREE-YEAR-OLD FILLIES, FOALED IN ONTARIO. By subscription of \$150 each, which shall accompany the nomination and an additional \$1,500 when making entry. The purse to be divided: 60% to the winner, 20% to second, 11% to third, 6% to fourth and 3% to fifth. Weight: 122 lbs.; Winners of a Sweepstakes of \$75,000 three times at a mile or over in 2009, additional 2 lbs.; Non-winners of a Sweepstakes of \$75,000 twice at a mile or over in 2009, allowed 3 lbs. Of a Sweepstakes of \$75,000 once at a mile or over in 2009, 5 lbs.; Of two races other than maiden or claiming or restricted allowance at a mile or over in 2009, 7 lbs. (Maiden or claiming races not considered.) (No Canadian Bred Allowance.) Final entries to be made through the entry box at the closing time then in effect for overnight events. A supplemental nomination may be made no later than the time of final entry, by a non-refundable fee of \$3,000, which includes the entry fee. *Plus up to \$13,200 Ontario Sired/Ontario Bred Breeder Awards.\$60,000 of this purse has been provided through the Thoroughbred Improvement Program. SOUL OF NATAKA raced off the pace, angled out and was hustled five-wide late turn, rallied determinedly and just got up, driving. FIRST CIRCLE set a reserved pace, turned back FOREST UPROAR and then DEEVEETEE upper stretch, drove clear but failed to contain the winner at the wire. FOREST UPROAR, rated close inside, bid at the top of the stretch, was no match but chased to the wire. DEEVEETEE, under strong early restraint but in touch, failed with a three-wide bid upper stretch, her rider having his whip knocked out of his hand and chased to the end. GORE BAY raced off the pace, saved ground, was contentious on the turn, finished gamely but evened out late. BEATRICE M. raced midpack three and four-wide, chased into the stretch then evened out late. MOONLIT BEAUTY stalked from between rivals, was hustled into the stretch, was jostled a bit and evened out late. VENGANZA, rated off the pace, angled from four-wide to six-wide on the turn then lacked a rally.
