**Footnotes**

BAG OF HAMMERS stalked the pace, angled out a bit but was boxed in late turn, cut to the inside at the top of the stretch, sprinted to the lead and widened under a drive. PAYNES GOLD, in range, angled out while being hustled late turn and rallied gamely to no avail. SABABA, in range, closed along the third path late turn, rallied inside then hung late. BAMMIAN raced off the pace, circled widest into the stretch and rallied in vain. GOLANI, well back early, was hustled through the turn then rallied mildly between foes. FREE TO FLY raced four-wide in range, closed late turn then evened out in deep stretch. ONE MORE DAY raced midpack, angled out hustling late turn then rallied seven-wide. JAZZ BOY, well back early, rallied between foes but never reached

contention. SORMANI, prominent on the backstretch, dueled through the turn, was headed upper stretch and tired. J T MORGAN, well back early, was hustled from midturn, encountered drive-stopping traffic midstretch, cut to the inside but was through. MYSTAMY raced four-wide on the first turn, bid four-wide into the far turn, dueled, yielded upper stretch and tired. JOEY D. pressed the pace, dueled on the backstretch, gave way midturn and tired. HOME RUCKUS led quickly, was joined early backstretch, dueled, gave way midturn and tired.
