CAT IN DEED gained a clear lead from the inside, came three wide into the stretch and drew off. TEE OFF TIME stalked the pace four wide, took the place position in the stretch. PUZZLE MAKER chased from off the rail, was outfinished for the place position. GINGERELLA stalked the pace three wide, and was not a threat. TEST OF COURAGE raced four to five wide, and was not a factor. BELLE DE NASKRA raced off the rail, gained mildly. TRIPLE VIXEN was three wide, and did not menace. CORONA DORADA stumbled at the start, raced five wide, and had no rally. PRIZE AND HONOR trailed, passed tired ones widest in the stretch. APACHE SIGNAL was inside, and showed little. NELSONSTREETNANCY raced four wide, and faded. ROBOTICA stalked the pace from the inside, dropped back on the turn.
