BELIEVE IN MISSY moved up between horses to take a short lead entering the backstretch, set the pace in hand but under pressure from CITI MUSIC, shook clear late turn and drew off then held under a strong hand ride. SWEET BAY closed along the rail late turn and finished gamely. EL NOEL chased three-wide from early turn and was all out in the stretch. STRIKE THE HARP stalked from the rail, steadied slightly in tight quarters entering the turn then finished gamely inside but to no avail. CITI MUSIC had a short early lead, was headed entering the main track, forced the issue to late turn and tired. DONNAS TRIAL well back early, raced on the third path through the turn and finished evenly without threatening. RAPTOR SPEED was hustled along the third path then tired at the top of the stretch. A CLAIM OF FOUL BY THE RIDER ON STRIKE THE HARP AGAINST SWEET BAY FOR INTERFERENCE AT THE 3/8 POLE WAS DISALLOWED.
