POWER OF ATTORNEY, in range, closed three-wide late turn, swept by upper stretch and prevailed, driving. COOM, in range, closed between rivals and angled out late turn then finished determinedly. DANDY WEE FELLA raced off the pace, saved ground, came two-wide late turn but needed more in the stretch. FLASHY N CLASSY broke alertly, stalked the pace, bid late turn, vied into the stretch then evened out. KARRMONIO raced off the pace, hustled three-wide late turn, came five-wide to the top of the stretch then tendered a mild rally. PIRATE'S LEGEND stalked, dropped back on the turn and finished evenly. CELERITY'S SUMMIT raced midpack along the rail, lacked a stretch response. FLASH OF TIME raced off the pace between horses and lacked a rally. VINTAGE MALT, well back early, was hustled four-wide but never threatened. GILFORD broke in the air, moved up quickly and took the lead, set the pace, was engaged late turn, vied into the stretch and tired. DAD'S FISHING led briefly, was headed, stalked the pace then tired at the top of the stretch. SUNNYS SON raced midpack, faded on the turn and tired.
