KRYSTAL SCEPTER gained ground on the leader into the stretch, bid outside in the drive, made contact with rival then ran on and was full out to prevail. ADREAMANDAPRAYER led the way and was in charge turning for home, took on outside challenge, was bumped then settled for second best. CLASSY GEM came from mid pack to put in an inside stretch bid but was not able to threaten the top two. CALVARY CHARGE in mid field and then between foes in the early going, had a mild off the rail gain but could not reach the first three finishers. NOT A LADY was well back before coming up with a late inside try.

MISS MCDREAMY off the pace then in the three path into the stretch, lacked the needed kick. HIGHLAND FLARE well back early then wide for the drive, was not a menace. LADY FINGERS raced in mid field and had no serious rally. BONCHICA BONBONBON was off the pace and showed little. INSTINCTIVEAFLEET was far back and never close. GOLD AMI had brief wide speed then was all done and faded. WEST COAST MISS showed nothing and was never in it. The rider of ADREAMANDAPRAYER lodged a claim of foul against the winner for alleged interference in the stretch run. After a review, the STEWARDS disallowed the claim of foul.
