CHATTY CAT showed brief speed, was headed midway of the first turn then stalked the pace from the rail, bid at the top of the stretch and moved clear quickly then held sway under a hand ride. WOVOKA, in range, stalked from between rivals, chased into the stretch, launched an all out drive but hung late. CREOSOTE raced midpack along the rail, was hustled late turn, finished gamely but evened out in the late stages. LA PERLA NEGRA raced off the pace

between horses, was three-deep on the far turn then lacked a strong closing response. SOARING SAPPHIRE raced off the pace, was hustled between rivals on the far turn but lacked a strong stretch rally. ALYSTAR LADY showed speed, shook clear on the first turn, set the pace, was engaged late turn and gave way at the top of the stretch. SOUTHERN RELATIONS stalked the pace from the backstretch, was roused three-wide late turn, chased into the stretch then tired. TUNEFUL TAYA raced off the pace, was hustled late turn, launched an all out drive inside but evened out late. FIRST PRIORITY, jostled at the start, raced well off the pace, came six-wide to the top of the stretch but never threatened. ONE WAY CARMA raced midpack between rivals, was in range late turn then flattened out in the stretch. C'MON SURPRISE ME's rider lost an iron leaving the gate then reset it, raced off the pace, was blocked entering the far turn and failed threatened. QUARTERMILE BELL raced midpack, lacked a rally. SHE'S AN ALLEY CAT, in range early, saved ground, was hustled on the far turn then tired in the stretch. A CLAIM OF FOUL BY THE JOCKEY ON FIRST PRIORITY AGAINST WOVOKA FOR INTERFERENCE AT THE START WAS DISALLOWED.
