Footnotes

RASHNAA raced off the pace, closed fast angling five to eight-wide through the turn, challenged upper stretch and drove clear. THREE HOUR TOUR raced midpack, closed then bid seven-wide late turn, dueled to the stretch, was headed, rebid a furlong out but was outfinished. SAN NICOLA WHISKEY raced midpack, closed on the turn, chased six-wide into the stretch, brushed with a rival upper stretch then finished all out. LITTLE B ROSSON raced off the pace, chased five-wide into the stretch, brushed with a rival, chased, then evened out late. MADAM INSPECTOR, steadied at the start, moved up close nearing the turn, was taken back and stalked the pace to the stretch then tendered a mild rally. DEEVEETEE showed speed, dueled, shook clear very briefly at the top of the stretch then tired a furlong out. KRZ EXEC had speed, dueled, yielded at the top of the stretch, chased hard, then flattened out late. GOLDEN GIRL SUE dueled, gave way late turn and tired. GEORGIA SONG dueled, was headed at the top of the stretch, rebid but failed to sustain the drive. LADY ELENA, off a step slowly, raced off the pace, angled from three to seven-wide on the turn then lacked a strong closing response.
