ESSENCES BEST, away alertly, set a pressured pace, shook clear on the turn, drifted out under left-handed encouragement through the stretch but held. SHARINA raced in midpack, was hustled four and five-wide on the turn, was all out through the stretch then was steadied late as the leader came out in front of her. STAR OF LIGHT, close early, chased four-wide on the turn and finished all out. LINDLU ANDJAN stalked the pace, chased five-wide late turn and finished determinedly. DRAVA broke in the air, settled off the pace, chased hard five-wide through the turn then rallied widest. DONNA'S BAD GIRL raced in midpack, was hustled two and three-wide on the turn then finished gamely between foes. PROXY LADY raced off the pace, was set down upper stretch, rallied, then evened out late. HEAVENLY MISSION forced the issue on the backstretch, was hustled late turn and was all out through the stretch. COUNTRY STYLE GIRL settled in midpack, chased four-wide late turn then evened out in deep stretch. FRANKS GIRL, close early, dropped back at the turn, was hustled along the rail then tired in the final 16th. POINTE CLAIRE, away slowly, raced off the pace, came five and six-wide through the turn and was never in contention. A CLAIM OF FOUL BY THE RIDER ON SHARINA AGAINST ESSENCES BEST FOR INTERFERENCE IN THE STRETCH WAS DISALLOWED.
