**Footnotes**

COUNTESS JUDITH was in hand along the rail stalking the early pace, came 3 wide in upper stretch and wore down rivals under a drive. BALLANTYNE was allowed to settle along the rail, drew even along the rail in upper stretch and got up for place. FOREVER FARMWAY was rushed to the early lead and unchallenged in the backstretch but gave way in mid stretch. SWEET LIL DANCER was unhurried early between horses, angled out in mid stretch and finished with a mild bid. LIVELY MELODY was allowed to settle along the rail then finished with a mild rally inside of rivals. FOXLEIGH RED was void of early speed off the rail then passed tiring rivals in the drive but was never a threat. LITTLE OPRAH was unhurried early, made a mild bid between horses in the turn but flattened out in the drive. ROSANA'S INTENTION was hustled along 3 wide then dropped back in the drive. VISALIA DUST was void of early speed off the rail and outrun. GROOVY BETH was hustled along in the four path then tired in the turn and dropped back.
