Footnotes

FREE TO FLY, well back early, closed late turn, came six-wide into the stretch, rallied and got by POINT TUPPER in deep stretch under a hand ride. POINT TUPPER, in range, closed into the stretch, took command a furlong out but failed to contain the winner in the late stages. CIRCLE BOUND, in range, was hustled late turn, rallied all out in the stretch but evened out late. GOLANI bobbled at the start, closed four-wide late turn and rallied mildly outside. BUDDHA N' SMART raced off the pace, chased three-wide late turn then evened out in the stretch. PORTERS COURT stalked the pace, was hustled three-wide on

the turn then evened out in the final sixteenth. NO MORE LAKES raced midpack, was hustled four then five-wide on the turn but lacked a stretch response. TEACHER BOYNE led early, set the pace, was passed a furlong out and tired. JOEY D. pressed the pace early, chased on the turn then tired in the final furlong. DEPUTY LOR raced off the pace along the rail, moved two-wide late turn, was game in the stretch but never threatened. COBRA CLASSIC raced off the pace three-wide, was hustled between foes on the turn but lacked a rally. ONE MORE DAY raced midpack, saved ground but lacked a rally.
