FOR TWO-YEAR-OLD FILLIES, FOALD IN ONTARIO. By subscription of \$150 each which shall accompany the nomination and an additional \$1,500 when making entry. The purse to be divided: 60% to the winner, 20% to second, 11% to third, 6% to fourth and 3% to fifth. Weight: 119 lbs. Winners of Sweepstakes of \$75,000 at a mile or over or a Sweepstakes of \$75,000 twice at any distance, additional 2 lbs.; Non-winners of a Sweepstakes of \$75,000 once, allowed 3lbs.; Of a race other than claiming, 5 lbs. MILWAUKEE APPEAL stalked the pace, closed into the turn, bid midturn, dueled into the stretch, drove clear a furlong out then held under steady handling. RETRACEABLE, in range outside rivals, closed four-wide late on the far turn, chased into the stretch and finished determinedly. D' COUNTRY led early, set a reserved pace, was engaged midway of the far turn, dueled into the stretch and yielded with a furlong to run. DANCE FOR US, rated off the pace, was three-wide on the far turn, closed six-wide into the stretch, was game but evened out late. STRANGER THINGS, rated off the pace, was in range three-deep on the far turn, chased into the stretch but lacked a late response. LUNAR LINDA, rated along the rail, stalked on the backstretch, chased inside rivals on the far turn then flattened out in the final furlong. GO WEST G T GO, unhurried early, was hustled five-wide into the far turn, chased to the stretch then flattened out. MOONLIT BEAUTY forced the pace in hand along the rail, gave way late backstretch and faded between rivals on the turn.
