ALIMIN kept close to the leader while on the inside, angled out to take on that one in the drive, took command and went clear. PETER THE GROSS had speed to lead the way into the turn while being pressed, was on the engine turning for home then caught but ran on willingly. MY KRYPTONITE had an inside trip, lost his path in early stretch while being steadied then came on again. MAN O' METTLE tracked and was never far back then put in a mild off the rail bid in the drive but could not best the top three. DISTINCT BY DESIGN chased the leaders and was in the eight path into the stretch then had a late try to no avail. PIVOTAL MOMENT was off the pace, angled in through the stretch but did not menace. WANDO'S APPEAL gained ground from well back but was never a threat. ESPIRITO had an inside off the pace trip and was never a factor. VIGILARE in touch while off the rail, was wide into the stretch then lost ground. D DUBAI bothered at the break, was in striking distance early, was widest into the stretch then faded. CAIT'S APPLE JACK pressed the early pace

into the turn then backed away. MEMYSELFANDI veered in at the break, was off the pace and never close. The rider of My KRYPTONITE lodged a claim of foul against the winner for alleged interference in the stretch. After a review by the STEWARDS, the claim of foul was disallowed.
