TOWN SCANDAL stalked the early pace from the outside, steadily advanced entering the turn, made a bid, dueled with MADISON COUNTYGIRL through the drive and inched clear of that one late. MADISON COUNTYGIRL dueled from the inside early, dueled through the stretch with the winner but could not match strides. PORT OF TEXAS outrun early, circled rivals on the turn, responded and finished well. BLAZING BARB forced the pace from the outside but had nothing left. AH SEE WAY could only pass tired ones. EXCLUSIVE TAB was no factor. TWOLEFTFEET forced the pace outside and tired. CART DELIVERS up close inside early, stopped entering the stretch and was taken up and vanned off.
